## For Calendar Year 2026

### Weekly Remittances

State and local discretionary sales tax, motor vehicle warranty fees, documentary stamp tax, nonrecurring intangible personal property tax, and red-light camera penalty collections must be remitted weekly. The municipality or county officer must complete the online transaction **before** 5 p.m. ET on the sixth working day following the close of the week in which the funds were received, as provided in section (s.) 219.07, Florida Statutes (F.S.).

### Monthly Remittances

**Clerks** - Court-related fees, service charges, court costs and fines must be remitted monthly. The Clerk must complete the online transaction before 5 p.m. ET on the last working day **before** the 10th day of the month immediately following the month in which the funds were collected, as provided in s. 28.245, F.S. \*All excess fees must be remitted quarterly as provided in s. 28.37(3), F.S.

**Medicaid** - Medicaid reimbursements must be remitted monthly. The county officer must complete the online transaction before 5 p.m. ET on the last working day **before** the fifth day of the month, as provided in s. 409.915(4), F.S.
