Remittance System Changes for statutory revisions effective August 2008

Updates to existing links

Court Related Fees I:

- **Filing Fees** – 27.52(1), \$49.00 (\$50 less 2%) application fee for petition for indigency
- **Filing Fees** – 27.562, First \$50 of all funds collected pursuant to s. 938.29 if not already paid pursuant to s. 27.52(1)(d)
- **Filing Fees** – 28.241(1)(a), \$80 of first \$85 in filing fees for circuit civil action
- **Filing Fees** – 28.241(1)(a), \$5 of first \$85 in filing fees for circuit civil action
- **Filing Fees** – 28.241(1)(a), One-third (1/3) of filing fees in excess of \$100 for circuit civil action
- **Filing Fees** – 28.241(2), First \$80 of \$280 (or \$80) appellate filing fee
- **Filing Fees** – 28.241(2), One-third (1/3) of appellate filing fee in excess of \$80
- **Filing Fees** – 34.041(1)(b), First \$80 of up to \$295 filing fee for county civil claims of more than \$2,500
- **Filing Fees** – 34.041(1)(b), One-third (1/3) of filing fee in excess of \$95 for county civil claims of more than \$2,500
- **Natural Resources and Conservation** – 379.407(1), Penalties for violation of Ch. 379
- **Natural Resources and Conservation** – 379.407(2), Additional penalties for major violations - saltwater fisheries
- **Natural Resources and Conservation** – 379.407(3), Penalties assessed for use of illegal nets
- **Natural Resources and Conservation** – 379.407(5), Additional penalties - saltwater products
- **Natural Resources and Conservation** – 379.2431, Penalties assessed - protection of marine animals

What's New for August 2008

- **Natural Resources and Conservation** – 379.403, \$250 fine for each criminal violation of Ch. 379 while in violation of Ch. 810 (illegal hunting while trespassing)
- **Natural Resources and Conservation** – 379.2203(3), All fines, penalties, bail forfeitures for violations regarding endangered or threatened species (379.3014, 379.409, 379.4115)
