Semi-Annual and Annual Sales Tax Filers'

1999 Tax Return Due

The enclosed sales and use tax return (DR-15SA) is due on January 1, 2000, and late if postmarked after January 20, 2000. Your collection period is printed on the return. Also enclosed is a return reply envelope for your convenience.

Annual Resale Certificate

Your 2000 Annual Resale Certificate is enclosed and may be found at the top of the page containing your 1999 DR-15SA Return.

Please carefully read the enclosed TIP (TIP # 99A01-34) regarding the changes in the resale provisions effective February 1, 2000.

Interest Rate Changes

Effective January 1, 2000, a floating rate of interest applies to underpayments and late payments of tax. The rates are updated January 1 and July 1 of each year by using the formula established in Section 213.235, Florida Statutes. To obtain interest rates contact the nearest Department of Revenue Service Center at the telephone number listed on the back or call Taxpayers Services at 1-800-352-3671 (in Florida only) or 850-488-6800.

Prepaid Telephone Calling Cards

Effective July 1, 1999, prepaid telephone calling cards are subject to Florida sales tax on telecommunications at the rate of 7 percent at the moment of sale to the customer. For further information on this law change please request TIP #99A01-18.

You may use the Department_s TeleFile system to file your return if no tax, penalty, or interest is due on your DR-15SA by

calling 1-800-550-6713. Telefile is available 24 hours, 7 days a week. Please have your certificate number ready when calling.

If your address or the status of your business has changed or changes in the future, please complete the enclosed Change of Address or Business Name form and return it to the Department.
